SAFTEY REPORT and PRINCIPAL'S REPORT – *Mr. Weeden and Dr. Rose Pollzie*

- New principal Mr. Weeden introduced himself
- Budget allocation is coming for next year, including staffing model
- Mr. Weeden plans to spend 50% of his time on instruction, still has some duties at Narcoosee

FUNDS REQUESTS

- Discussed bowling equipment funding request with Dr. Straker (oversees SAC) and he approved SAC funds for gym equipment under the school culture portion of the SIP, per SAC vote (SAC approved at the previous meeting). The equipment will stay within the school
- As per our previous meeting, if it was determined that SAC funds could be used on the request the vote from the last meeting that was passed would stand.
